An unusual opportunity is offered by this property which is two detached buildings both contemporary but of traditional brickwork cladding surmounted by duo pitched clay tiled covered roofs contained within a fully fenced and electronic gated site providing efficient circulation and at least twenty six marked vehicle parking spaces with much potential for additional parking.

The Green House is currently used as warehousing on the ground floor with administrative office use on the first floor but this office use is formed by fully demountable and flexible partitioning.

Electric House is currently in administrative office use on both floors but again all existing partitioning is readily removable for a change of the use or configuration of the interior.

These are buildings and a site with potential for many different uses and occupy this prominent position with vehicular access off Forties but with a long and visible frontage to the very busy Ninian Way, the principal distributor road via Tame Valley Industrial Estate which is also in much use as a commuter route.

The intersection of the A5 and M42 at junction 10 is within five minutes drive to the east and Tamworth town centre a similar distance away to the north. This is a location fully accessible to both local users and commuters.

Electric House has a gross internal area of 2,799 sq.ft. (260.1 sq.m.) and is on two floors and is fully heated by wet radiator gas fired central heating, has double glazed window inserts and is fitted internally with suspended ceilings having recessed lighting and skirting cable trunking.

Part of this building is currently occupied under a number of licences as serviced office space currently producing £6,296 per calendar month net of applicable VAT. Full details and copies of the Agreements can be provided upon request. The vendors advise that these licences are readily determinable. A purchase can be made retaining these licences in place or alternatively the vendors will undertake to provide full vacant possession.

The Green House has electrically heated water filled underfloor heating system and has double glazed window inserts. Again it is fitted out complete with skirting cable trunking and suspended ceilings with inset lighting.

To the exterior the site is fully tarmacadam surfaced.


